- Departure times will be assigned for the start. Detailed race instructions will be mailed to registered participants.
- All registered participants completing the course in under six hours will be entered into a drawing to win a two night stay at a Dog Creek 6 person cabin. *(\$80 value)*
- 1st place in both division – 2 night stay at a 6 person cabin at either Mill Creek or Dog Creek *(\$80 value)*
- 2nd place in both divisions - 5 nights of camping at either Mill Creek or Dog Creek *(\$75 value)*
- Additional t-shirts on sale at the Prairie Heritage Center.
- Lunch will be sold at the center by the Little Sioux Valley Conservation Association after 12:00 p.m.
- **Rules:**
 - Canoes must be propelled by paddles only – NO MOTORS ALLOWED.
 - Two paddles allowed in the canoe.
 - All participants must have adequate life jackets on board and wear them in high water conditions.
 - Participants must provide their own canoes, paddles and life jackets.
 - Canoe transport, delivery and pick-up are the responsibility of the participant.
 - Participation in this event is at “your own risk.”
